

**Charge Media Partners 2021 Armorers Class Sweepstakes
Official Rules**

and documented travel expenses associated with said class; select shooting gear to be determined at Sponsor's sole discretion with an approximate retail value of One Thousand Dollars (USD\$1,000.00); and one year Firearms Legal Protection Premium Membership (choice of Individual or Family Premium, contingent on the winner's state of residence being a state where Firearms Legal Protection can be sold) with an approximate retail value of Four Hundred Dollars (USD\$400). Total approximate retail value ("ARV") is Two Thousand Nine Hundred Dollars (USD\$2,900.00).

Limit one (1) prize. Odds of winning depend on the number of eligible Entries received.

NOTE: To qualify for the Heckler & Koch armorer training class voucher, the class must be chosen from a calendar of pre-scheduled classes and taken between November 15, 2021 and November 15, 2022. Civilian, Law Enforcement and Military style classes shall be offered within the approved timeframe. However, to attend a Law Enforcement or Military style class, proof of current active service will be required. To qualify for the one year Firearms Legal Protection Premium Membership, the winner must reside in a state where Firearms Legal Protection can be sold.

With exception of the conditional travel allowance described above, the Grand Prize does NOT include airfare, transportation, or any travel related incidentals to and from the class location prior to or after the specified trip dates. The winner is responsible for booking and paying for all travel arrangements, hotel stays, lodging, and provisions prior to and after the specified trip dates.

Credit cards are recommended, as this is generally the quickest method and funds must be received before the application process can begin. This fee is non-refundable, regardless of cancellation, date change, student substitution or application disapproval. Please include payment information on the student registration form.
2. Completed student registration form for each student attending.

3. Legible copy of current Passport for each student.
4. A memorandum on Department/Agency letterhead stationary containing the following:
 - o Department or Agency
 - o Name of Student/Students
 - o Nationality of the Student/Students
 - o Date of Birth of Student/Students
 - o Type of Training Requested (ex: MP5/BTG Armorer).
 - o Dates of Training Requested (ex: JAN 11-13, 2011)
 - o Dollar Amount of Tuition (# of students x \$XXX.00 ea – application fee is separate)
 - o Location of Training (ex: Ashburn, VA)

*We must allow for at least 10-12 weeks in advance for Heckler & Koch to process your application and receive approval from the US Department of State upon Heckler & Koch's receipt of the above mentioned documents and application fee. Tuition payment is required prior to the start date of the course, once approved.
